### Leadership MRL

## Rail Safety Act 2008

In October, Congress passed the Rail Safety Improvement Act of 2008. Several changes will have an impact on the industry, including Montana Rail Link and several crafts of employees. Those employees most significantly impacted are those covered by hours-of-service regulations. In addition, the act mandates Positive Train Control systems for Class 1 railroads and some others. As of now, MRL will not be required to install this system, however crews operating on BNSF track may be required to do so. Certain crafts or classes of employees will be required to be certified under programs similar to locomotive engineers in the near future. Additional employees will be required to be included in Federal Alcohol and Drug Testing Programs; this will most likely include Maintenance of Way employees. FRA has been allocated additional funds to increase the number of inspectors, and civil penalties were increased significantly.

Those employees covered by hours-of-service regulations are train, yard and engine service, dispatchers, as well as some signal and Mechanical Department hostlers. Major provisions of the hours-of-service regulations include an increase of off-duty time from 8 hours to 10 hours of

undisturbed rest for all covered service employees, effectively adding an additional four hours off between duty assignments for those on call. Train, yard and engine service employees, including hostlers, cannot exceed 276 hours on-duty in any calendar month; this provision should impact very few employees. Those employees reporting for duty on six consecutive calendar days must be unavailable for service for a minimum of 48 hours, and those returning to their home terminal on the seventh consecutive calendar day must have 72 hours off.

**Several changes will have an impact on Montana Rail Link and several crafts of employees.**

MRL will be required to make necessary changes to the operation in order to ensure we are in full compliance with the act. Over the next few months prior to the July effective date, Montana Rail Link will be discussing changes with employees and their representatives to be certain of full compliance, while minimizing the impact on our operation.

## ACCOUNTING

*Linette Lemm, Brent Mueller and Michelle Watt; Accounting Department*

A quote often heard in the business world advises companies to "not step over a dollar to pick up a dime." The goal of the MRL Accounting Department is to make sure there isn't any currency lying on the ground to be stepped over when picking up the dimes. While many railroads have their accounting departments located in a distant office, our company size enables our accounting employees to work directly with folks in every department across our system. Leading the Accounting group of 21 dedicated employees is **David Koerner**, VP and Chief Financial Officer, with **Jean Laber** as Director of General Accounting and **Mark Krause** as Director of Revenue/Cost Accounting. The MRL accounting staff is divided into various groups of financial responsibilities with Payroll, Inventory Management, Car Repair Billing, Accounts Payable, and General Accounting reporting to Jean Laber. The groups reporting to Mark Krause are Car Hire, Freight Claims, Freight Car Revenue, Cost Accounting, and Real Estate Administration.

Most employees are familiar with Payroll's staff; represented by **Patty Seabaugh**, **Shelly Goff** and **Cindy Smith**. **Lynda Hahn** manages Inventory's material for maintenance of way, B&B, signal, and Mechanical's locomotive and car shops. **Dawn Taylor** manages Car Repair billing, which involves approving repair bills of the MRL freight cars and invoicing other railroads for freight car repairs made by the mechanical shops. Accounts Payable's **Kelly Hayes**, **Debbie Bush** and **Jennifer Bristow** have the large task of keeping track of all the bills and making sure they are paid on time and coded correctly. **Julie Devlin** and **Wanda Russell** administer Car Hire, the usage fees railroads pay and collect from one another for use of each other's freight cars. **Linette Lemm**, **Dawn Dodson** and **Mary Ann Buck-Heisserer** make up the Revenue Accounting group with responsibilities for tracking loaded and empty freight car moves and associated accessorial revenue due MRL. In Cost Accounting, **Brent Mueller** manages special projects involving audits and

proposed capital purchases, assists in customer rate calculations, measures locomotive utilization and lease, and publishes quarterly reports identifying locomotive costs and Laurel yard operating cost; where MRL and BNSF share expenses. Recent additions to our group are **Theresa Beckwith** and **Bev Kenfield**, who joined MRL from Washington Corp.'s real estate department and will continue administering the MRL real estate holdings. Finally, **Michelle Watt** and **Chris Cline** administer multiple general accounting functions interacting with MRL's other departments handling expense coding, financial reporting, miscellaneous billing, and fuel usage accounting just to name a few.
